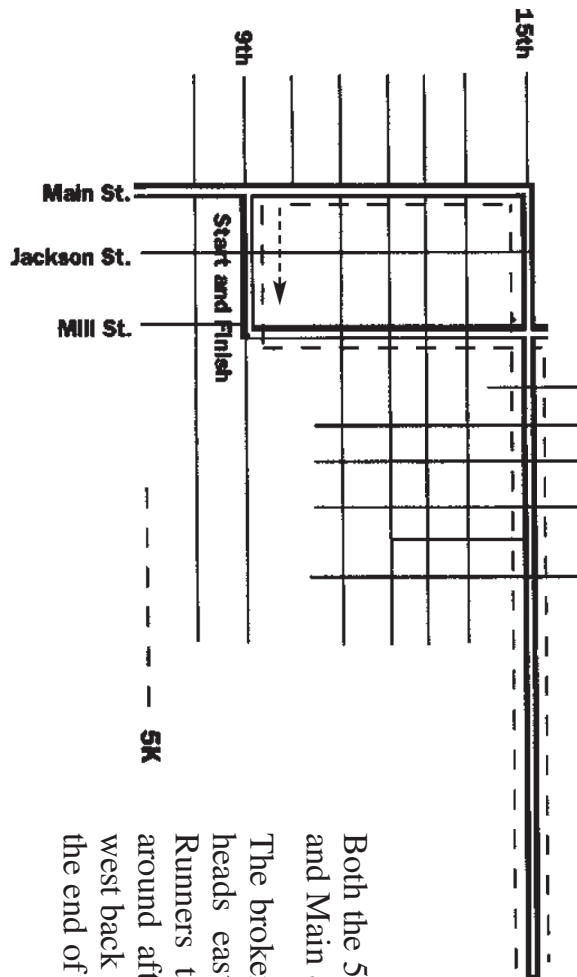

### The Route

Both the 5K race and walk begin and end at 9th and Main Street in Jasper, Indiana.

The broken line indicates the course. The course heads east, then turns north onto Mill Street. Runners turn east onto 15th Street, then turn around after the Patoka River bridge and head west back to Main Street, where they turn south to the end of the race at 9th and Main Street.

# Strassenfest Wettlauf

## Date:

Saturday, August 1, 2009

## Time:

Registration desk opens at 6:30 a.m.  
Both the 5K Run and the 5K Walk begin at 8:00 a.m.

## Place:

Registration and the start of the race take place on Main Street between 8th and 9th Street in Jasper, Indiana.

## Awards:

Awards will be presented to the first three places in each division of the male and female categories in the 5K Run. Also, an award will be presented to the overall winner in both the male and female categories. Participants will receive a unique Strassenfest Wettlauf t-shirt (while supplies last). All t-shirts and awards are courtesy of Memorial Hospital and Health Care Center.

## Refreshments:

Free refreshments including fruit, energy bars, and water will be available at the end of the race.

## Race Divisions:

For men and women:  
0-14 years of age, 15-19, 20-29, 30-39, 40-49, 50-59, 60-69, 70 and over

## The Course:

The 5K run includes rolling, paved city streets. The route is well-marked, policed, and has ample water stations. There will be mile splits.

## Entry Fees:

### 5K Run:

The entry fee is \$15.00 before Wednesday, July 29th and \$18.00 on the day of the race.

### Fitness Walk:

The entry fee is \$14.00 before Wednesday, July 29th and \$18.00 on the day of the walk. Because this is a fitness walk, no times or awards will be distributed.

Children under 12 years old can enter the walk or run for \$10.00.

## Registration:

Advanced entry may be made with the attached registration and liability forms. Late entries will be taken between 6:30 a.m. and 7:30 a.m. the day of the race at 9th and Main Street.

Pre-registrants should pick up their packets the day of the race.

*Only a limited number of t-shirts of varying sizes are ordered. Size requests will be honored while supplies last.*

## After the Races:

The Wettlauf is part of a four-day German festival in Jasper. It begins on Thursday, July 30th and continues through Sunday, August 2nd, 2009. The fest features numerous booths, rides, exhibits, concessions, events, and competitions in the Jasper area while celebrating the German heritage with a "Street Festival" or Strassenfest.
